WHAT DOES 1ST SUMMIT BANCORP OF JOHNSTOWN INC., 1ST SUMMIT BANK AND CAMBRIA THRIFT CONSUMER DISCOUNT COMPANY DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and checking account information

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons 1ST SUMMIT BANCORP, 1ST SUMMIT BANK and Cambria Thrift Consumer Discount Company choose to share; and whether you can limit this sharing.

What we do	
How does 1ST SUMMIT BANCORP, 1ST SUMMIT BANK and Cambria Thrift Consumer Discount Company protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does 1ST SUMMIT BANCORP, 1ST SUMMIT BANK and Cambria Thrift Consumer Discount Company collect my personal information?	We collect your personal information, for example, when you: open an account or apply for a loan deposit money use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: ■ sharing for affiliates' everyday business purposes- information about your creditworthiness ■ affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional

rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?	Your choice will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include companies with a common corporate identity of 1ST SUMMIT BANCORP, financial companies such as 1ST SUMMIT BANK, and Cambria Thrift Consumer Discount Company.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. ■ 1ST SUMMIT BANCORP, 1ST SUMMIT BANK and Cambria Thrift Consumer Discount Company do not share with nonaffiliates so they can market you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. ■ 1ST SUMMIT BANCORP, 1ST SUMMIT BANK and Cambria Thrift Consumer Discount Company do not jointly market.
