How does 49er Federal Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We maintain procedural safeguards that comply with federal regulations and leading industry practices to safeguard your nonpublic information.
How does 49er Federal Credit Union collect my personal information?	We collect your personal information, for example, when you:

Why can't I limit all sharing? What happens when I limit sharing for an account I hold jointly with someone else?	Federal law gives you the right to limit only § sharing for affiliates' everyday business purposes—information about your creditworthiness § affiliates from using your information to market to you § sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. Both individuals' information is no longer shared with the affiliates of 49er Federal Credit Union. Either member may opt-out.
