Archer Cooperative Credit union is committed to making available financial products and services that will enable our members to meet their financial needs and reach their financial goals. Protecting personal information and using it in a manner consistent with member expectations is a high priority for everyone associated with our credit union.

Members of our credit union have a responsibility to safeguard their information.

To ensure that members can rely on the quality of products and services the credit union makes available, our credit union will adhere to the following policies:

FACTS WHAT DOES ARCHER COOPERATIVE CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?		
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The type of personal information we collect and share depend on the accounts or services you have with us. This information can include: <ul style="list-style-type: none"> Name, address, Social Security Number and income Account balances and payment history Credit history, credit scores and employment history 	
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list reason financial companies can share their members' personal information, the reasons Archer Cooperative Credit Union chooses to share; and whether you can limit this sharing.

What We Do		
How does Archer Cooperative Credit Union protect my personal information?	We maintain strict policies and security controls to assure that member information in our computer systems and files is protected. Our employees and agents are permitted access to member information that they may need to perform their jobs and to provide service to you. our employees and agents have access to such member information as necessary to conduct a transaction or respond to your inquiries. All employees and agents have regular access to the Credit Union computer system and records storage. The Credit Union has established internal security controls, including physical, electronic, and procedural safeguards to protect the information you provide us and the information we collect about you. We will continue to review our internal security controls to safeguard your member information as we employ new technology in the future.	
How does Archer Cooperative Credit Union collect my personal information?	We collect your personal information, for example when you: <ul style="list-style-type: none"> Open an account Apply for a loan Use your credit or debit card Pay your bills Make deposit to or withdrawals from your accounts We also collect your personal information from others, including credit bureaus and other companies.	
Why can't I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> Sharing for affiliates' everyday business purposes—information about your creditworthiness

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else? You choices will apply to everyone on your account—unless you tell us otherwise.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <i>Archer Cooperative Credit Union has no affiliates</i>
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <i>Archer Cooperative Credit Union does not share with non-affiliates so that they can market to you.</i>
Joint marketing	A formal agreement between non-affiliate financial companies that together market financial products or services to you. Our marketing partner include: <i>Other financial service providers</i>
