FACTS	What does Atascosa National Bank do with your personal information?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p><i>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</i></p> <ul style="list-style-type: none">• Social Security number• Credit History• Account balances• Overdraft history• Transaction history• Checking account information <p><i>When you are no longer our customer, we continue to share your information as described in this notice.</i></p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Atascosa National Bank chooses to share; and whether you can limit this sharing.

What We Do	
How does Atascosa National Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Atascosa National Bank collect my personal information?	<p><i>We collect your personal information, for example, when you</i></p> <ul style="list-style-type: none"> • Open an account • Pay us by check • Make deposits or withdrawals from your account • Make a wire transfer • Give us your contact information <p><i>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</i></p>
Why can't I limit all sharing?	<p><i>Federal law gives you the right to limit only</i></p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes - information about your creditworthiness • affiliates from using your information to market to you • sharing for nonaffiliates to market to you <p><i>State laws and individual companies may give you additional rights to limit sharing.</i></p>

Definitions	
Affiliates	<p><i>Companies related by common ownership or control. They can be financial and non-financial companies.</i></p> <ul style="list-style-type: none"> • Atascosa National Bank does not share with our affiliates.
Nonaffiliates	<p><i>Companies not related by common ownership or control. They can be financial and non-financial companies.</i></p> <ul style="list-style-type: none"> • Atascosa National Bank does not share with nonaffiliates so they can market to you.
Joint	<i>A formal agreement between nonaffiliated financial companies that together market</i>

financial products or services to you.

Other Important Information

For Alaska, Illinois, Maryland and North Dakota Customers. *We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization.*

For California Customers. *We will not share personal information with nonaffiliates either for them to market to you or for joint marketing - without your authorization. We will also limit our sharing of personal information about you with our affiliates to comply with all California privacy laws that apply to us.*

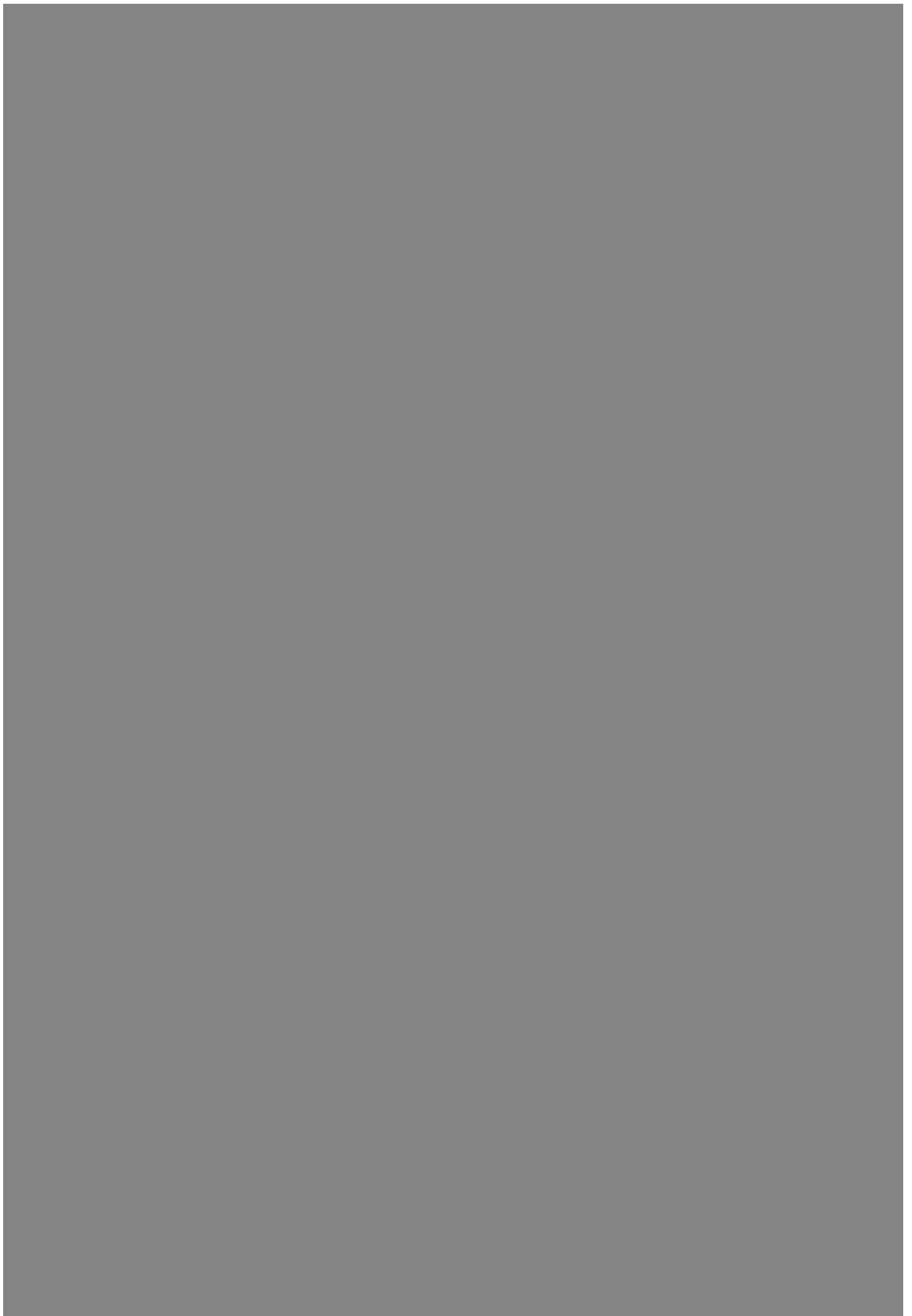

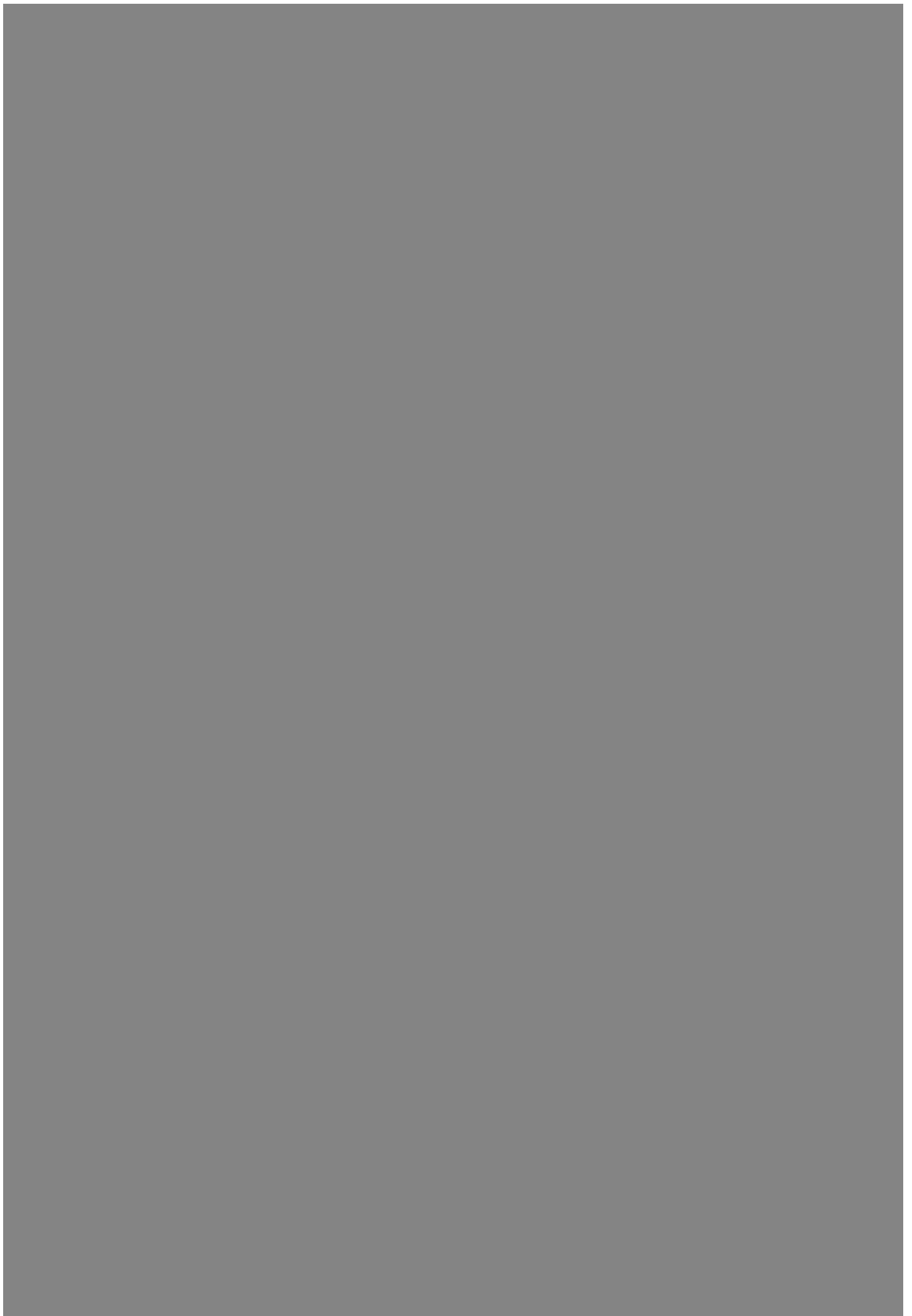


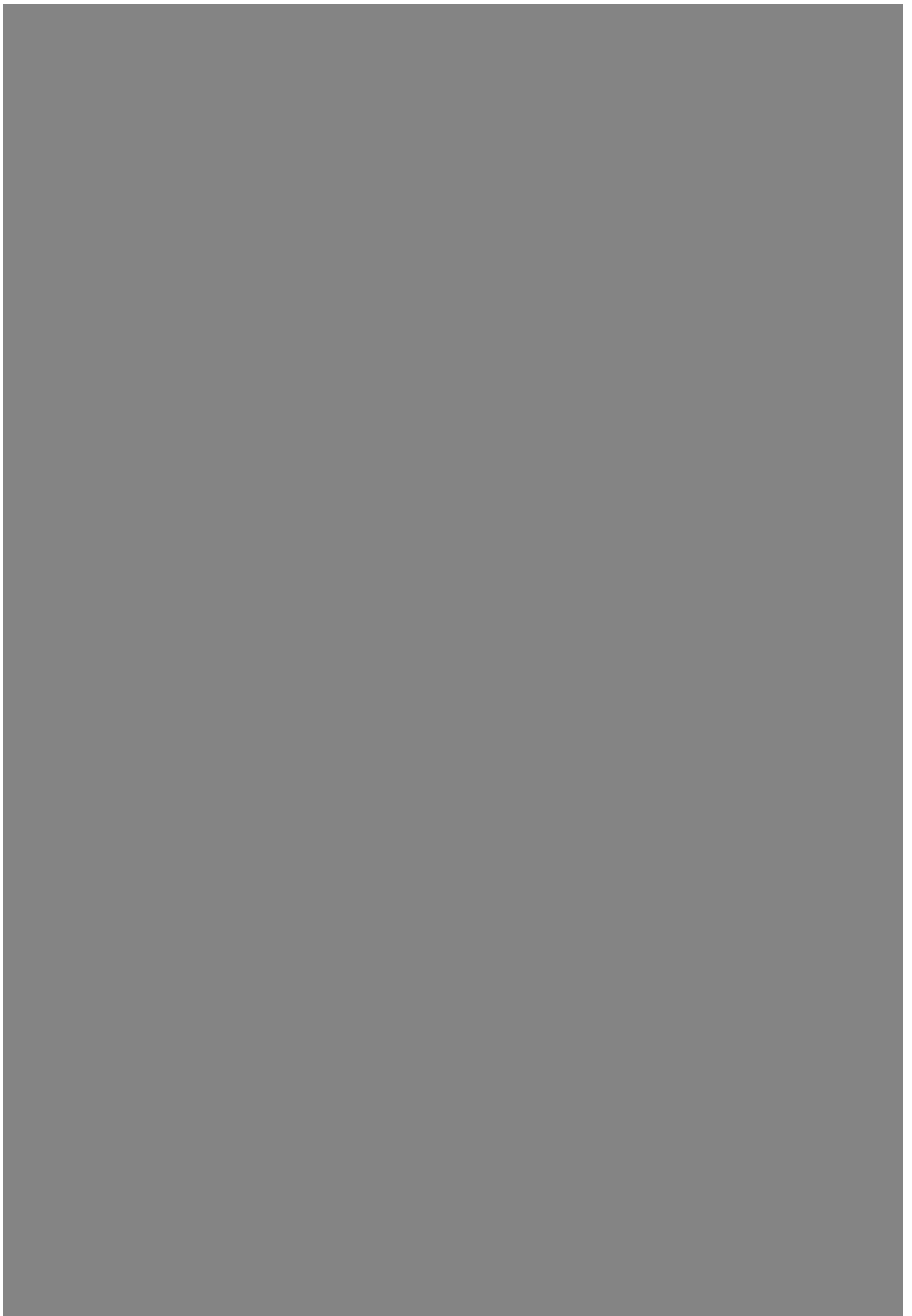
Notice of changes in temporary FDIC insurance coverage for transaction accounts: By operations of federal law, beginning January 1, 2013, funds deposited in a noninterest bearing transaction account (including an Interest on Lawyer Trust Account) no longer will receive unlimited deposit insurance coverage by the Federal Deposit Insurance Corporation (FDIC). Beginning, January 1, 2013, all of a depositor's accounts at an insured depository institution, including all noninterest-bearing transaction accounts, will be insured by the FDIC up to the standard maximum deposit insurance amount (\$250,00.00), for each deposit insurance ownership category. 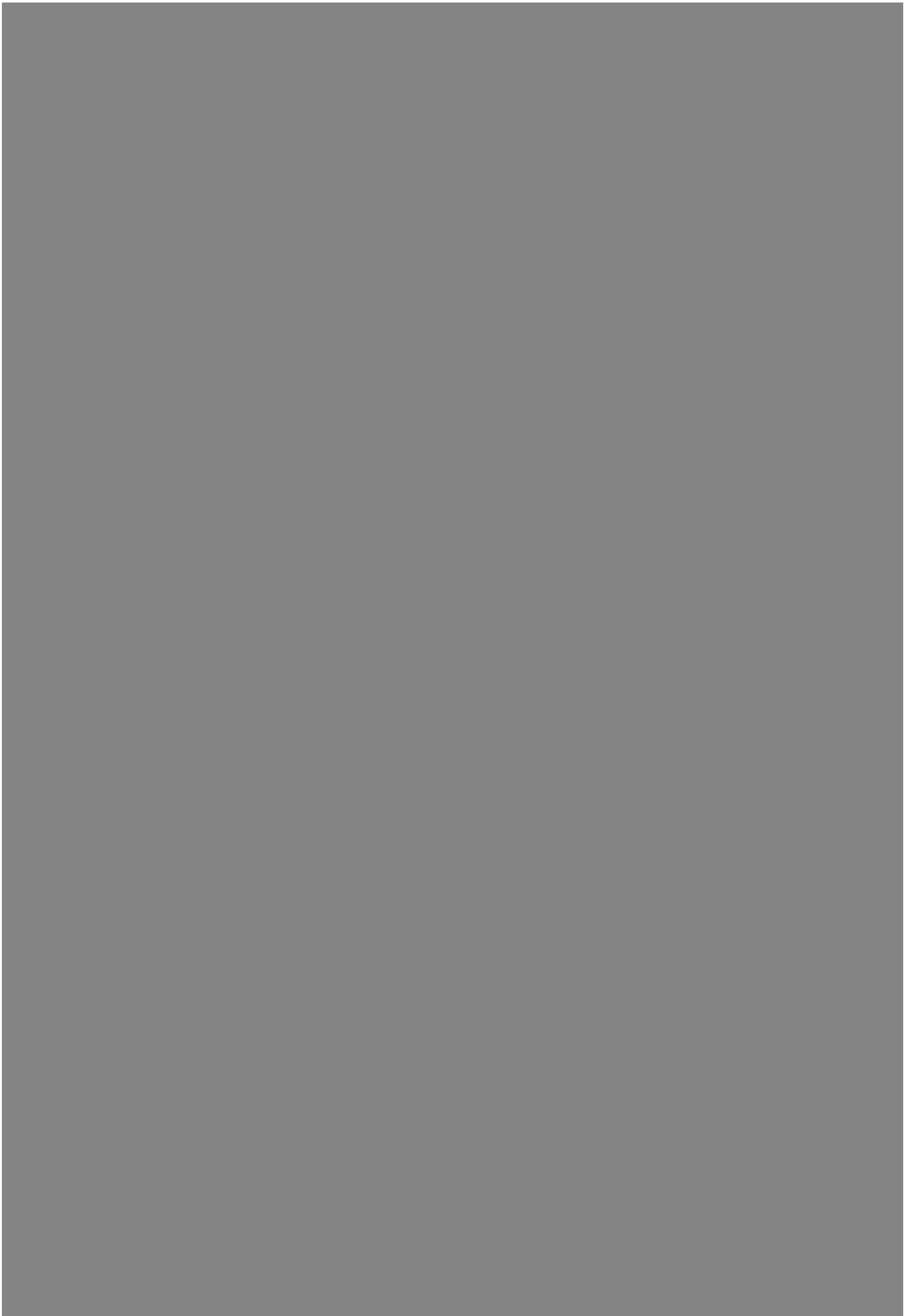


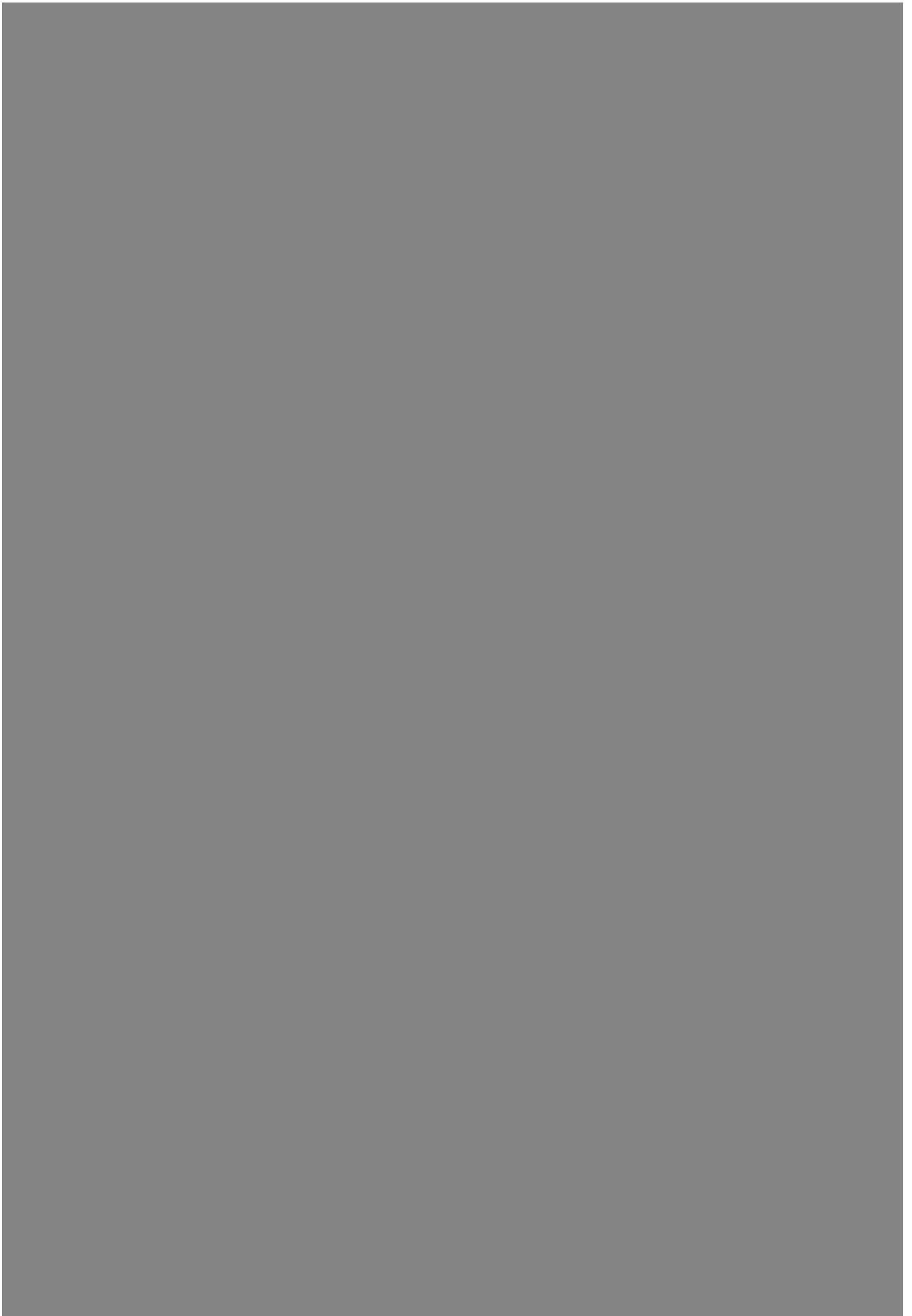


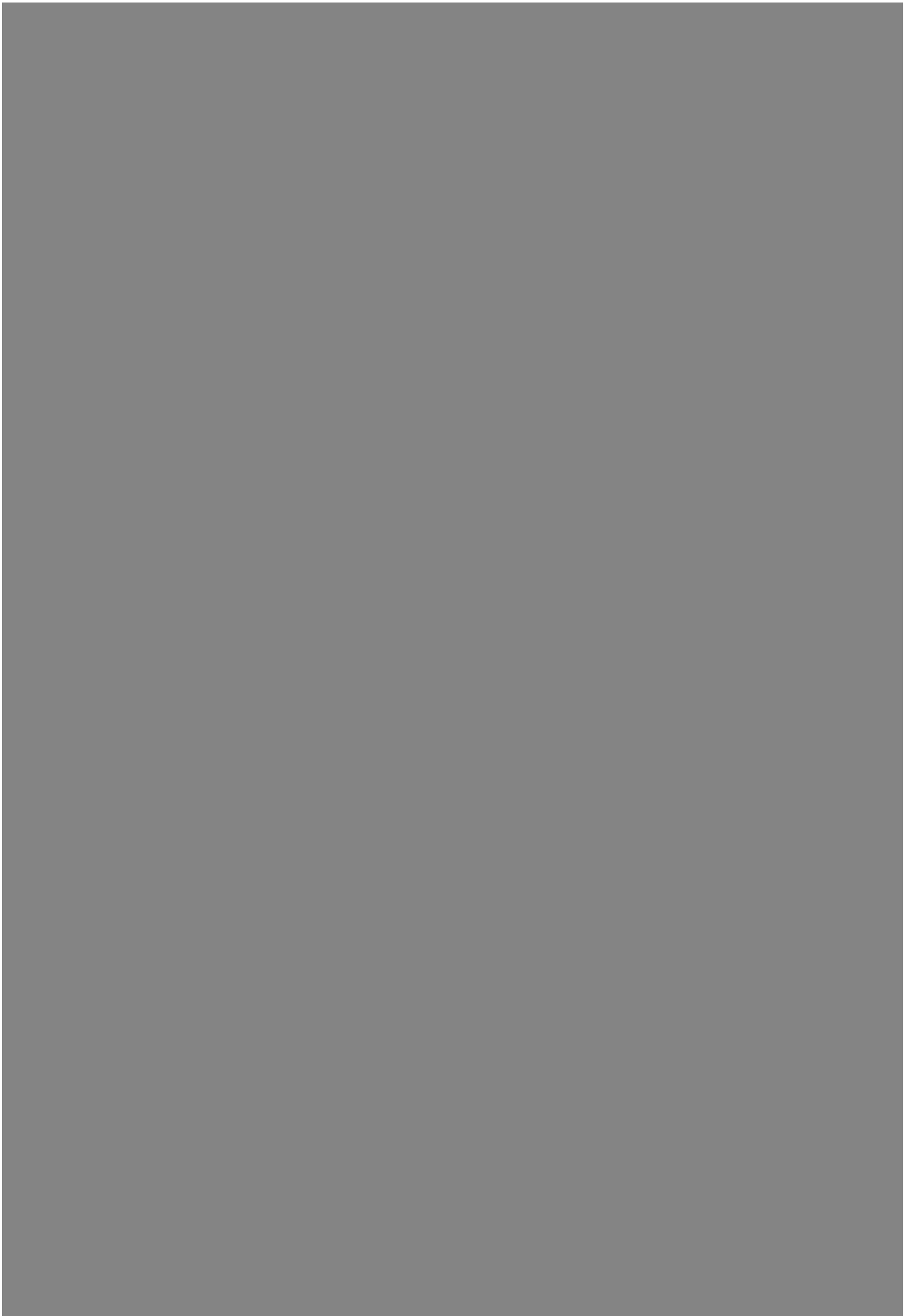
