| How does Bank of Charles Town<br>protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal<br>law. These measures include computer safeguards and secured files and buildings.<br>We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to<br>information to those employees for whom access is appropriate.                                    |
| How does Bank of Charles Town<br>collect my personal information? | <ul> <li>We collect your personal information, for example, when you</li> <li>Open an account</li> <li>Apply for a loan</li> <li>Give us your contact information</li> <li>Make a wire transfer</li> <li>Show your driver's license</li> <li>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</li> </ul>  |
| Why can't I limit all sharing?                                    | <ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.</li> </ul> |

| Definitions   |   |

| Affiliates    | Companies related by common ownership or control. They can be financial and non-financial companies. <ul> <li>Bank of Charles Town does not share with its affiliate holding company Potomac Bancshares.</li> </ul> |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and non-financial companies. <ul> <li>Nonaffiliates we share with can include financial service companies.</li> </ul>                   |

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

Our joint marketing partners include a financial service company and a credit card company.
