Why can't I limit all sharing?	<ul> <li>Federal law gives you the right to limit only</li> <li>sharing for affiliates' everyday business purposes – information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> <li>State laws and individual companies may give you additional rights to limit sharing. Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include companies with a common ownership by Capitol Bancorp Limited. For a listing, please see "Our Affiliates" at www.capitolbancorp.com.</li> </ul>
Nonaffiliates	<ul> <li>Companies not related by common ownership or control.</li> <li>They can be financial and nonfinancial companies.</li> <li>Bank of Maumee does not share with nonaffiliates so they can market to you.</li> </ul>
Joint Marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>Our joint marketing partner(s) include a broker-dealer. However, no information, including contact information, is shared with this broker-dealer until we</li> </ul>
