| What? | The types of personal information we collect and share depend on the product or service you have with us. This information can include:• Social Security number• Transaction or loss history• Payment history• Credit history• Transaction history• Mortgage rates and paymentsWhen you are <i>no longer</i> our customer, we continue to share your information as described in this notice. | | |
| How? | All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Bank of St. Francisville chooses to share; and whether you can limit this sharing. | | |

| How does Bank of St. Francisville protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. | |
| How does Bank of St. Francisville collect my personal information? | We collect your personal information, for example, when you Apply for a loan Make deposits or withdrawals from your account Provide employment information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. | |
| Why can't I limit all sharing? | Federal law gives you the right to limit only sharing for affiliates' everyday business purposes - information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. | |
| Definitions | | |
| Affiliates | Companies related by common ownership or control. They can be financial and non-financial companies. Bank of St. Francisville has no affiliates. | |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and non-financial companies. Bank of St. Francisville does not share with nonaffiliates so they can market to you. | |
| Joint Marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Bank of St. Francisville doesn't jointly market. | |
