What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and account balance Assets and income Payment history and credit history When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. 		
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons BankPacific , Ltd. chooses to share; and whether you can limit this sharing.

How does BankPacific, Ltd. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.		
	We restrict employee access to customer information to only those who have a business reason to know such information.		
How does BankPacific, Ltd. collect my personal information?	 We collect your personal information, for example, when you Open an account or apply for a loan Make a wire transfer or show your government-issued ID Make deposits or withdrawals from your account We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. 		
Why can't I limit all sharing?	 Federal law gives you the right to limit only Sharing for affiliates' everyday business purposes – information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 		
Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. BankPacific, Ltd. does not share with our affiliates. 		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. BankPacific, Ltd. does not share with nonaffiliates so they can market to your		
Joint Marketing	market to you. A formal agreement between nonaffiliated financial companies that together market financial products or services to you.
