Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.			
What?	The types of personal information we colect and share depend on the product or service you have with us. This information can include: Social Security number and Income Account Balances and Payment History Transaction History and Credit History			
How?	All financial companies need to share customer's prsonal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons BANKWEST OF KANSAS chooses to share; and whether you can limit this sharing.

Definitions			
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. BANKWEST OF KANSAS has no affiliates		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies Non affiliates that we share with can include service providers, data processors, credit analysis systems and credit reporting agencies.		
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. ■ Our joint marketing partners include Intuit Financial Services
