FACTS	WHAT DOES BEAUMONT COMMUNITY CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: • Social Security number and income • Account balances and payment history • Credit history and credit scores When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
HOW?	All financial companies need to share member's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their member's personal information, the reason Beaumont Community Credit Union chooses to share, and whether you can limit this sharing.

What We Do	
How does Beaumont Community Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Beaumont Community Credit Union collect my personal information?	We collect personal information when you: Open an account or deposit money Pay your bills or apply for a loan Use your credit card or debit card We also collect your personal information from others such as, credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: • Sharing affiliates' everyday business purposes information about credit worthiness • Affiliates' from using your information to market to you • Sharing with non-affiliates for marketing to you
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account, unless you tell us otherwise

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial or non-financial companies
Non-affiliates	Companies not related by common ownership or control. They can be financial or non-financial companies
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you
