How does protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does collect my personal information?	We collect your personal information, for example, when you

	State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Our affiliates include financial companies (such as CUSO Financial Services LP); non-financial companies (such as Centennial Lending LLC); and others (such as Student CU Connect CUSO LLC).</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.
	<ul> <li>Nonaffiliates we share with can include insurance companies and financial service providers.</li> </ul>
Joint marketing	A formal agreement between Bellco Credit Union and a nonaffiliated financial company where we jointly market financial products or services to you.
	<ul> <li>Our joint marketing partners include insurance companies and financial service providers.</li> </ul>
