# iCashe Wallet Terms & Conditions – Boulder Valley Credit Union

## 1. Mobile Application

Credit Union offers its members mobile access to merchant prepaid card programs via a Mobile Banking Application. Credit Union also offers mobile access to a member's purchased gift card information via a Mobile Application Program. To use the features of the Mobile Banking application, additional message terms and data rates may apply.

#### 2. Support Carriers

Include AT&T, Sprint, Nextel, Boost, Verizon Wireless, U.S. Cellular, T-Mobile, Cincinnati Bell, Virgin Mobile USA, Cellular South, Centennial, Ntelos.

# 3. Purchases

In order to acquire gift cards or transfer value to existing accounts displayed through this application your member account must be linked to enable online transfers of value from your member account to a Credit Union account that will be used to complete your transactions. Every transfer of value from your member account must be authorized by you, in advance, before transfer will be made. The act of making a transaction (even under consideration that the electronic signoff is somehow avoided), confirms that you agree to pay all related charges (including product, service, shipping & handling, and taxes) incurred by you or any users of mobile banking application. Credit Union reserves the right to refuse an order or terminate merchant prepaid services for any reason.

#### 4. Privacy

Certain data relative to the activity of your user session may be collected. This information as well as information provided through the process of making transactions may be used by Credit Union to improve the offering or provide promotional information to you. Please review our Privacy Policy for privacy related terms.

# NOTICE OF PRIVACY POLICY

# 1.0 FACTS - WHAT DOES BOULDER VALLEY CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

## 1.1 Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand Boulder Valley Credit Union's Privacy Policy.

At Boulder Valley Credit Union, we respect the privacy of our members. We recognize the importance of maintaining the confidentiality of your personal financial information. This notice describes the privacy policy and practices followed by Boulder Valley Credit Union. This notice explains what types of member information we collect and under what circumstances we may share it.

## 1.2 What?

The types of personal information we collect and share depend on the accounts or services you have with us. This information can include:

\* Name, address, Social Security number, and income

\* Account balances and transaction history

\* Credit history and transaction or loss history

When you are no longer our member, we will not share your information except as permitted or required by law, as described in this notice.

## 1.3 How?

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Boulder Valley Credit Union chooses to share; and whether you can limit this sharing.

1.4 Reasons we can share your personal information

1.4.1 For our everyday business purposes - such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus

1.4.2 For our marketing purposes - to offer our products and services to you

1.4.7 For non affiliates to market to you

\* Does Boulder Valley Credit Union share? - No

\* Can you limit this sharing? - We don't share

1.5 Who we are? Who is providing this notice? Boulder Valley Credit Union

1.6 What we do

1.6.1 How does Boulder Valley Credit Union protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also restrict access to nonpublic personal information about you to those employees and volunteers who need to know the information to provide products or services to you.

1.6.2 How does Boulder Valley Credit Union collect my personal information?

We collect your personal information, for example, when you

\* open an account or apply for a loan

\* apply for any credit union service

\* visit our website, provide us information on any online application or transaction, or information you send to us by email.

\* use your credit or debit card or pay your bills

\* make deposits to or withdrawals from your accounts

We also collect your personal information from others, including credit bureaus or other companies.

1.6.3 Why can't I limit all sharing?

Federal law only gives you the right to limit information sharing as follows:

\* sharing for affiliates' everyday business purposes-information about your credit worthiness

\* affiliates from using your information to market to you

\* sharing for non affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

1.7 Definitions

1.7.1 Affiliates

Companies related by common ownership or control. They can be financial and non financial companies. \* Credit Union Service Group, LLC, a provider of financial services, including insurance products.

1.7.2 Non affiliates

Companies not related by common ownership or control. They can be financial and non financial companies.

\* Boulder Valley Credit Union does not share with non affiliates so they can market to you, except for our joint marketing arrangements.

1.7.3 Joint marketing

A formal agreement between Boulder Valley Credit Union and a non affiliated financial company where we jointly market financial products or services to you.

\* Our joint marketing partners include investment and financial service providers and insurance companies.
