| How does CAP COM FCU protect my personal information? | To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. Our emoployees are fully educated about the importance of maintaining confidentiality of member/client records. |
| How does CAP COM FCU collect my personal information? | We collect your personal information, for example, when you Open an account or give us your contact information Apply for a loan or provide us income/credit information Apply for a product/service where such information is necessary We also collect your personal information from other sources such as credit bureaus, affiliates, or other companies. |
| Why can't I limit my sharing? | Federal law gives you the right to limit only Sharing for affiliates' everyday business purposes - information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. |
| What happens when I limit sharing for an account I hold jointly with someone else? | Your choices will apply to everyone on your account. |

| Affiliates | Companies related by common ownership or control. They can be financial and nonfinancial companies. Our subsidiary companies round out our complement of services and include CAP COM Financial Services LLC, MorPac/Advantage Mortgage, Old Heritage Title Services, and Car Buyers Helpline | |
| Nonaffiliates | Companies not related by common ownership or control. They can be financial and nonfinancial companies. • CAP COM FCU does not share your information with nonaffiliated companies so they can market to you. | |
| Joint Marketing | A format agreement between nonaffiliated financial companies that together market financial products or services to you. • CAP COM FCU may enter into arrangements with non-affiliated companies to provide you with information regarding products and/or services that complement those offered by the Credit Union | |

Other Important Information

There is no need to take any action unless you choose to opt out from receiving marketing promotions or services directly from our affiliated subsidiaries. If you elect to limit marketing offers directly from our subsidiaries it will apply for five (5) years from the time you inform us of this election. Please note that you may receive promotional notices directly from CAP COM FCU in regard to products and services offered by our affiliated subsidiaries which does not require that we share your information with our subsidiaries.
