How does Capitol National Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We restrict access to your personal information to our employees who need the information to properly service your account(s), act upon your requests, or to provide you products or services.

Why can't I limit all sharing?	Federal law gives you the right to limit only  sharing for affiliates' everyday business purposes – information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you  State laws and individual companies may give you additional rights to limit sharing. Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  **Dur affiliates include companies with a common ownership by Capitol Bancorp Limited. For a listing, please see "Our Affiliates" at <a href="www.capitolbancorp.com">www.capitolbancorp.com</a> .	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  Capitol National Bank does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Dur joint marketing partner(s) include a broker-dealer. However, no information, including contact information, is shared with this broker-dealer until we obtain your permission.
