How does CharterBank collect my personal information?	 We collect your personal information, for example, when you: Open an account or make deposits or withdrawals from your accounts Apply for a loan or show your driver's license Use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes - information about your creditworthiness Affiliates from using your information to market to you Sharing for nonaffiliates to market to you State laws and individual companies may give
Definitions	you additional rights to limit sharing.
Definitions Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. CharterBank does not share with our affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. → CharterBank does not share with nonaffiliates so they can market to you.
