FACTS	WHAT DOES CHEVRON VALLEY CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:	
	 Social Security number and account transactions account balances and payment history credit card or other debt and wire transfer instructions 	
	When you are <i>no longer</i> our member, we continue to share your information as described in this notice.	
How?	All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their mem bers' personal information; the reasons Chevron Valley Credit Union chooses to share; and whether you can limit this sharing.

How does Chevron Valley Credit Union protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Why can't I limit all sharing?	Federal law gives you the right to limit only

	State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.		

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies <i>Chevron Valley Credit Union has no affiliates.</i>	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies	
	 Nonaffiliates we share with can include companies such as mortgage bankers or insurance agents. 	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.	
	• Our joint marketing partners include mortgage bankers or insurance agents.
