WHAT DOES CHISHOLM TRAIL STATE BANK DO WITH YOUR PERSONAL INFORMATION?

Why2

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Numbers and income
- Account balances and account transactions
- Credit history and payment history

When you are no longer our customer, we continue to share your information as described in this notice

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Chisholm Trail State Bank chooses to share; and whether you can limit this sharing.

What we do

How does Chisholm Trail State Bank protect my personal information? To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Chisholm Trail State Bank collect my personal information? We collect your personal information, for example, when you

- Open an account or make a deposit
- Pay your bills or apply for a loan
- Use your credit or debit card

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non financial companies. • Chisholm Trail State Bank has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non financial companies. • Chisholm Trail State Bank does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Chisholm Trail State Bank doesn't jointly market.
