What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:	
	 Social Security number and account balances credit history and income payment history and account transactions 	
	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.	
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons CITIZENS BANK OF PAGOSA SPRINGS chooses to share; and whether you can limit this sharing.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • CITIZENS BANK OF PAGOSA SPRINGS has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • CITIZENS BANK OF PAGOSA SPRINGS does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • CITIZENS BANK OF PAGOSA SPRINGS doesn't jointly market.
