Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Account balances

How?

All financial companies need to share customers' personal information to run their everyday business. Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • Citizens National Bank of Texas has one affiliate; Town Square Title Co.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Citizens National Bank of Texas does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Citizens National Bank of Texas doesn't jointly market.
