Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies • <i>Citizens State Bank has no affiliates</i> .
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.
Joint Marketing	<ul> <li>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</li> <li><i>Citizens State Bank doesn't jointly market.</i></li> </ul>
