Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <ul> <li>Non-affiliates we share can include investment services.</li> </ul>			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  City National Bank of New Jersey doesn't jointly market.
