Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • City of Raleigh ECU has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Nonaffiliates we share with can include insurance companies.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • City of Raleigh ECU doesn't jointly market.
