Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Our affiliates include companies with a Community Savings Bank name; financial companies such as Community Safe Deposit Vault Company, CSLA Corporation, and Community Insurance Agency.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  Community Savings Bank does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Community Savings Bank doesn't jointly market
