Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.Conestoga Bank does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies.Conestoga Bank does not share with nonaffiliates so that they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.Conestoga Bank does not jointly market.
