This information can include</p> <ul style="list-style-type: none"> • Social Security number and income • Account balances and payment history • Credit history and credit scores <p>When you are <i>no longer</i> our customer we continue to share your information as described in this notice.</p> | |
| How? | All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reason Cornerstone Community Bank chooses to share; and whether you can limit this sharing. | |

| How does Cornerstone Community Bank protect my information? | <p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>To protect the information you provide us online, we use computer virus detection software and employ various technical means to protect against unauthorized computer entry into systems containing customer information.</p> |
| How does Cornerstone Community Bank collect my personal information? | <p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> • open an account or deposit money • pay your bills or apply for a loan • use your credit or debit card <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p> |
| Why can't I limit all sharing? | <p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes-information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you. <p>State laws and individual companies may give you additional rights to limit sharing (see below for your rights under state law).</p> |
| Definitions | |
| Affiliates | <p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> • <i>Cornerstone Community Bank has no affiliates.</i> |
| Non-affiliates | <p>Companies not related by common ownership or control. They can be financial or non-financial companies.</p> <ul style="list-style-type: none"> • <i>Cornerstone Community Bank does not share with non-affiliates so they can market to you.</i> |
| Joint Marketing | <p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you</p> <ul style="list-style-type: none"> • <i>Cornerstone Community Bank doesn't jointly market.</i> |

| <p>Under California law Cornerstone Community Bank does not share personal information except as allowed by law for everyday business purposes.</p> <p>USING OUR ELECTRONIC MEDIUM - Our customers and other individuals visiting our web site are important to us.
