Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Non- affiliates we share with can include government entities and credit bureaus.
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or service to you.
