How does Elsa State Bank & Trust Co. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  We also maintain other physical, electronic and procedural safeguards to protect this information and we limit access to information to those employees for whom access is appropriate.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  • Elsa State Bank & Trust Co. has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  • Elsa State Bank & Trust Co. does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Elsa State Bank & Trust Co. doesn't jointly market.
