FACTS	What does Farmers & Merchants State Bank of Bushnell do with your personal information?
<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>What?</b>	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security number and income</li> <li>• Account balances and payment history</li> <li>• Credit history and account balances</li> </ul> When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons <b>Farmers &amp; Merchants State Bank of Bushnell</b> chooses to share; and whether you can limit this sharing.

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does Farmers & Merchants State Bank of Bushnell collect my personal information?**

We collect your personal information, for example, when you:

- Open an account or apply for a loan
- Show your driver's license or provide employment information
- Make deposits or withdrawals from your account

We also collect your personal information from other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

**Definitions****Affiliates**

Companies related by common ownership or control. They can be financial and non financial companies.

- **Farmers & Merchants State Bank of Bushnell** does not share with our affiliates.

**Non Affiliates**

Companies not related by common ownership or control. They can be financial and non-financial companies.

- **Farmers & Merchants State Bank of Bushnell** does not share with non-affiliates so they can market to you.

**Joint Marketing**

A formal agreement between non affiliated financial companies that together market financial products or services to you.

- **Farmers & Merchants State Bank of Bushnell** does not jointly market.

**Other important information**

Illinois law requires that you opt-in to information sharing. Therefore, before we would share your information with a third party, except where permitted by law, we will obtain your permission.
