Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non financial companies.  • Farmers State Bank does not share with our affiliates
Non affiliates	Companies not related by common ownership or control. They can be financial and non financial companies.  • Farmers State Bank does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.  • Farmers State Bank does not market jointly.
