What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include:  • Social Security Number and transaction or loss history  • account balances and payment history  • credit history and credit scores  When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Fidelity Bank chooses to share; and whether you can limit this sharing.
