Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • First Community Bank of Bedford County does not share customer's information with Affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • First Community Bank does not share customers' information with any Nonaffiliates.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • First Community Bank does not share customers' information for joint marketing purposes.
