Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.



The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and credit history
- income and payment history
- credit score and account balance

When you are no longer our customer, we continue to share your information as described in this notice.

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • First Delta Bank has no affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • First Delta Bank does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. First Delta Bank doesn't jointly market.
