## Privacy Policy

### FACTS WHAT DOES FIRST FEDERAL BANK OF OHIO DO WITH YOUR PERSONAL INFORMATION?

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social security number, name, and address
- Types of accounts and account balances
- Account activity, deposit history, and payment history
- Credit history, credit scores, and income

When you are *no longer* our customer, we continue to share your information as described in this notice.

**How?** All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons First Federal Bank of Ohio chooses to share; and whether you can limit this sharing.

<p><b>protect my personal information?</b></p>	<p>To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.</p> <p>We restrict access to information about you to those employees who need to know that information to provide products or services to you.</p>
<p><b>How does First Federal Bank of Ohio collect my personal information?</b></p>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>open an account or deposit money</li> <li>pay your bills or apply for a loan</li> <li>apply for and use your credit or debit/ATM card</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<p><b>Why can't I limit all sharing?</b></p>	<p>Federal law gives you the right to limit only sharing for affiliates' everyday business purposes-- information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you</p> <p>State laws and individual companies may give you additional rights to limit sharing.</p>

### Definitions

<p><b>Affiliates</b></p>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><i>First Federal Bank of Ohio may disclose information about you to financial service providers, such as securities broker-dealers &amp; insurance agents.</i></p>
<p><b>Nonaffiliates</b></p>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p><i>First Federal Bank of Ohio does not share information with nonaffiliates other than as described above.</i></p>
<p><b>Joint marketing</b></p>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p><i>First Federal Bank of Ohio does not participate in joint marketing.</i></p>
