FACTS	WHAT DOES FIRST IPSWICH BANK DO WITH YOUR PERSONAL INFORMATION
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> Social Security number and credit history Account transactions and overdraft history Account balances and transaction history When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customer's personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customer's personal information; the reasons First Ipswich Bank chooses to share; and whether you can limit this sharing.

What we do	
How does First Ipswich Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We regularly test and evaluate our information security measures, train employees and adopt enhancements as necessary to protect your information.
How does First Ipswich Bank collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> open an account or apply for a loan use your debit card or provide account and contact information make deposits or withdrawals from your account We also collect your personal information from others, such as credit bureaus or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> sharing for affiliates' everyday business purposes —

Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <ul style="list-style-type: none"> • <i>Our affiliates include companies that with us are under common control of Brookline Bancorp such as Brookline Bank, Bank Rhode Island and financial companies such as:</i> <ul style="list-style-type: none"> ◦ <i>investment management companies</i> ◦ <i>insurance agencies</i> ◦ <i>leasing and realty companies</i>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial or non-financial companies.</p> <ul style="list-style-type: none"> • <i>First Ipswich Bank does not share with non-affiliates so they can market to you.</i>
Joint marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> • <i>Our joint marketing partners may include: mortgage, insurance companies and investment advisors.</i>
