How does FIRST MISSOURI STATE BANK OF CAPE COUNTY protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does FIRST MISSOURI STATE BANK OF CAPE COUNTY collect my personal information?	We collect your personal information, for example, when you: apply for a loan or open an account make a wire transfer or tell us where to send money show your driver's license
Why can't I limit all sharing?	Federal law gives you the right to limit only: sharing for affiliates' everyday business purposes - information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.

Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • FIRST MISSOURI STATE BANK OF CAPE COUNTY does not share with our affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • FIRST MISSOURI STATE BANK OF CAPE COUNTY does not share with nonaffiliates so they can market to you.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • FIRST MISSOURI STATE BANK OF CAPE COUNTY doesn't jointly market.
