What we do			
How does Florida Bank of Commerce protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.		
	Florida Bank of Commerce will make every reasonable effort to maintain the highest level of security against any unauthorized access to your financial information. In this regard we will use tight security procedures, employee training and technology.		

How does Florida Bank of Commerce collect my personal information? We collect your personal information, for example, when you

- Open an account or deposit money
- Pay your bills or apply for a loan
- Use your dehit or credit card

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

# Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  • Florida Bank of Commerce does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Florida Bank of Commerce does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • Florida Bank of Commerce does not jointly market.
