of Northern California protect my personal information?	we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does First National Bank of Northern California collect my personal information?	 We collect your personal information, for example, when you open an account or deposit money pay your bills or apply for a loan use your credit or debit card We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you
