FACTS	What does Generations Bank do with your personal information?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and account balances payment history and overdraft history credit history and checking account information When you are no longer our customer, we continue to share your information as described in this notice.
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Generations Bank chooses to share; and whether you can limit this sharing.

What we do	
How does Generations Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Generations Bank collect my personal information?	We collect your personal information, for example, when you open an account or deposit money pay your bills or apply for a loan make deposits or withdrawals from your account.

	We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing? Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. • Generations Bank does not share with our affiliates.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Generations Bank does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Generations Bank doesn't jointly market.
