Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include financial companies, such as our parent bank holding company.</li> </ul>		
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial or nonfinancial companies.</li> <li>Bonneville Bank does not share with nonaffiliates so they can market to you.</li> </ul>		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul> <li>Bonneville Bank does not jointly market.</li> </ul>
