Privacy Policy

Protecting your privacy is important to Heartland National Bank and our employees. We want you to understand what information we collect and how we use it. In order to provide our customers with a broad range of financial products and services as effectively and conveniently as possible, we use technology to manage and maintain customer information. The following policy serves as a standard for all Heartland National Bank employees for collection, use, retention, and security of nonpublic personal information.

FACTS

WHAT DOES HEARTLAND NATIONAL BANK DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend upon the product or service you have with us. This information can include:

- Social Security number
- Payment history
- Income
- Transaction or loss history
- Account balances
- Credit history

When you are *no longer* our customer, we continue to share your information as described in this notice

How?

All Financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Heartland National Bank chooses to share; and whether you can limit this sharing.

Affiliates	Companies related by common ownership or control. They can be financial or non-financial companies.

Non-affiliates	Companies not related by common ownership or control. They can be financial or non-financial companies.	
	 Heartland National Bank does not share with non-affiliates so they can market to you. 	
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.	
	Heartland National Bank does not jointly market.	

Our Security Procedures

We also take steps to safeguard customer information. We restrict access to your personal and account information to those employees who need to know that information to provide products or services to you. Employees who violate these standards will be subject to disciplinary measures.

We maintain physical, electronic and procedural safeguards that comply with federal standards to guard your nonpublic personal information. We make use of firewalls and routers to filter what traffic is allowed into our network from the Internet. Intrusion Detection and Prevention systems are in place to alert bank staff and prevent attacks from occuring on bank systems. Additionally, we use antivirus and anti-spam systems in our network to ensure the added security of customer data.
