What we do					
To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. • Heritage Community Bank does not share with non-affiliates so they can market to you.	
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. • Heritage Community Bank does not jointly market.
