WHAT DOES HICKORY POINT BANK DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and credit scores

When you are *no longer* our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share **customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers'** personal information; the reasons Hickory Point Bank & Trust chooses to share; and whether you can limit this sharing.

What we do

How does Hickory Point Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We educate our employees about the importance of confidentiality and customer privacy and we restrict employee access based on need.

How does Hickory Point Bank collect my personal information?

We collect your personal information, for example, when you

- Open an account or apply for a loan
- Deposit money or pay us by check
- Show your government-issued ID

We also collect your personal information from others, such as credit bureaus or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. (See below for more on your rights under State Law)

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Hickory Point Bank and Trust does not share with our affiliate.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *We make disclosures to non affiliates to process transactions, maintain account(s), respond to court orders and legal investigations, or report to credit bureaus; or as permitted by law.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include advertising agencies.*

Other important information

It is the policy of Hickory Point Bank and Trust to follow the rules of the Privacy of Consumer Financial Information in all cases except where Illinois Law prevails.
