FACTS	WHAT DOES HIGHLAND COMMERCIAL BANK DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Highland Commercial Bank chooses to share; and whether you can limit this sharing.

What We Do

How does Highland Commercial Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We also maintain other physical, electronic (including multifactor authentication) and procedural safeguards to protect this information and we limit information access to those employees for whom access is appropriate.

How does Highland Commercial Bank collect my personal information?

We collect your personal information, for example, when you:

- Open an account
- Use your credit or debit card
- Apply for a loan
- Make deposits or withdrawals from your account
- Make a wire transfer

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only:

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and non-financial companies.

- *Highland Commercial Bank has no affiliates.*

Non-affiliates

Companies not related by common ownership or control. They can be financial and non-financial companies.

- *Highland Commercial Bank does not share with non-affiliates for them to market to you.*

Joint Marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Highland Commercial Bank doesn't jointly market.*
