FACTS	WHAT DOES HORIZON CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share Your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires Us to tell You how We collect, share, and protect Your personal information. Please read this notice carefully to understand what We do.
What?	The types of personal information we collect and share depend on the product or service You have with Us. This information can include: • Social Security number and income • account balance and payment history • credit history and credit scores
	All financial companies need to share customers' personal

information to run their everyday business. In the section below, We list the reasons financial companies can share their customers' personal information, the reasons Horizon Credit Union chooses to share, and whether You can limit this sharing.

What We do	
How does Horizon Credit Union protect my personal information?	To protect Your personal information from unauthorized access and use, We use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Horizon Credit Union collect my personal information?	We collect Your personal information, for example when You • open an account or deposit money • pay Your bills or apply for a loan • use Your credit or debit card We also collect Your personal information from others, such as credit bureaus, affiliates, or others.
Why cant I limit all sharing?	Pederal law gives You the right to limit only In sharing for affiliates' everyday business purposes information about Your creditworthiness In affiliates from using Your information to market to You In sharing for non-affiliates to market You State laws and individual companies may give You additional rights to limit sharing.

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. Horizon Credit Union has no affiliates.
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Horizon Credit Union does not share with non-affiliates so they can market You.
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products of services to You. Our joint marketing partners include categories of companies, such as:
