FACTS	INFORMATION?	
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.	
What?	The types of personal information we collect and share depend on the product or service you have with us. How does Intervest National Bank protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We limit employee access to customer information to those who have a business reason to know such information. We educate our employees about the importance of confidentiality and customer privacy.	
How does Intervest National Bank collect my personal information?	 We collect your personal information, for example, when you open an account or deposit money apply for a loan or make a wire transfer show your driver's license We also collect your personal information from others, such as credit bureaus, affiliates or other companies.	
Why can't I limit all sharing	 Federal law gives you the right to limit only: sharing for affiliates' everyday business purposes-information about your creditworthiness affiliates from using your information to market to you sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 	
Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and non- financial companies. Intervest National Bank has no affiliates. 	
Non-affiliates	Companies not related by common ownership or control. They can be financial and non- financial companies. Intervest National Bank does not share with non-affiliates so they can market to you. 	
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. Intervest National Bank does not jointly market.
