How?	All financial companies need to share customers' personal information to run their everyday business. Nonaffiliates	Companies not related by common ownership or control. They can be financial and non-financial companies • Jefferson Security Bank does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Jefferson Security Bank does not jointly market.
