Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. • Lake County Bank has no affiliates
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Lake County Bank does not share with nonaffiliates so they can market to you
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Lake County Bank doesn't jointly market
