| Nonaffiliates | Companies not related by common ownership or control. They can be financial and nonfinancial companies. <i>LMCU does not share with nonaffiliates.</i> | | | |
| Joint Marketing | A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Our joint marketing partners include insurance and student loan companies. | | | |
