In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Lawrenceburg Federal Bank chooses to share; and whether you can limit this sharing.

What we do

How does Lawrenceburg Federal Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

We may ask personal information that only you as an account holder would have knowledge.

How does Lawrenceburg Federal Bank collect my personal information?

We collect your personal information, for example, when you

- Apply for a loan or deposit money
- Give us your contact information or give us your income information
- Make a wire transfer

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes-information about your • creditworthiness
- Affiliates from using your information to market to you
- Sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates Companies related by common ownership or control. They can be financial and nonfinancial companies.

Lawrenceburg Federal Bank has no affiliates.

- Nonaffiliates Companies not related by common ownership or control. They can be financial and nonfinancial companies.
 - Lawrenceburg Federal Bank does not share with nonaffiliates so they can market to you.
 - Joint A formal agreement between nonaffiliated financial companies that together Marketing market financial products or services to you.
