FACTS

WHAT DOES LCE FEDERAL CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Name and Address
- Loan balances and payment history

When you are no longer our member, we continue to share your information as described in this notice.

How?

All financial companies need to share non-public personal information to run their everyday business. In the section below, we list the reasons financial companies can share their non-public personal information; the reasons LCE Federal credit Union chooses to share; and whether you can limit this sharing.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes-information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for non-affiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates	<input type="checkbox"/> Companies related by common ownership or control. They can be financial and non-financial companies. <input type="checkbox"/> We have no affiliates
Non-affiliates	<input type="checkbox"/> Companies not related by common ownership or control. They can be financial and non-financial companies. <input type="checkbox"/> We will not disclose your nonpublic personal information to nonaffiliated third parties, except as permitted by law. <input type="checkbox"/> We do not share with nonaffiliates
Joint marketing	<input type="checkbox"/> A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <input type="checkbox"/> Cuna Mutual Group
